

# Foal Registration Checklist

You cannot get from here...

...unless we have all the right info.

- Name Choice:** Numbers, dashes and accents on letters are not permitted. Please ensure names are legible.
- Foal Date:** Must contain the complete Month, Day and Year of foaling.
- Sex, Colour & Pattern:** Choose the gender and coat colour that currently apply. Do not check Gelding if your colt is not yet castrated. Foals that have a grey parent may turn grey, although this is not always evident at the time of registration. Gender (gelding) & Colour Changes may be done after registration if necessary at no charge. For Partbreds, please ensure you check SOLID if foal has no pattern.
- Sire & Dam Registration Info:** Correct registration numbers **MUST** be provided. Partbreds must provide Registry & Reg.# of non-Arabian parents or indicate GRADE. Anglo foals must include a copy of the Thoroughbred parent's registration papers. Dams that foal out in Canada must be CAHR/CPAR registered prior to applying for the foal's registration (this includes IAHA registered partbreds).
- Sire/Dam Colour:** Ensure you fill in the *colour* and not the coat *pattern* (ie: Bay or Black, etc not Pinto/Tobiano/Sabino, etc)
- Owner of Dam at Foaling:** This is whoever is RECORDED in our system as the owner of the dam as of the foal date. If you have leased the dam, we still require the *recorded owner's* signature in this section. The owner of the dam at foaling is always the first owner of the foal.
- Owner of the Dam at Breeding:** This is whoever is recorded in our system as the owner of the dam as of the date she was bred. This may be a different owner than the owner at the time of foaling. If you have leased the dam and want to be listed as the breeder, the *recorded owner at the time of breeding* may sign an Assignment of Breeder Designation (separate form). \*This does not entitle you to sign as owner at time of foaling.
- Transported Semen Service:** If the mare was bred by this method, the ORIGINAL Transported Semen Service Certificate must be submitted to the registry along with the foal application. This certificate is provided by the Stallion Owner. \*This section only applies to Purebred foals.
- Service Certificate:** Must include Sire and Dam information, method of Breeding and COMPLETE date(s) of breeding including MONTH(s), DAY(s) and YEAR. If a mare had an abnormally long or short gestation, please include a note indicating so to avoid getting an error letter.
- Owner of Stallion at Breeding:** This is whoever is recorded in our system as the owner of the sire as of the date(s) the mare was bred. \*This section is not required for Purebred foals when breeding is done by Transported Semen.
- Transfer Report:** Complete this section if the foal is to be Transferred to a new owner upon registration. The first owner of the foal is ALWAYS the recorded owner of the Dam at the time of Foaling. The appropriate signature(s) is/are required along with the complete date of sale (which can be no earlier than the foaling date of the foal).
- MARKINGS:** The written description must correspond with the markings drawn. The markings required are *white hair* (pink skin on greys). If you have a GREY foal, please read the instructions regarding pink skin at the top of the Markings section. Ensure all 4 views of the legs are drawn. It is a common mistake to miss one view or to draw a marking on the incorrect leg. Whorls should be marked with an X only. *Note:* The markings drawn on the application are copied "as is" to the back of the certificate. Please limit unnecessary marks or writing in this section.
